With reference to Stewards' Decision No. 1 at WRC Rally Italia Sardegna 2016 (Document No. 2.3) concerning the above Competitor No. 21 Jipocar Czech National Team, the Stewards consider that a new element has been brought forward which justifies the application of the 2016 FIA International Sporting Code Article 14 (Right of Review).

In taking the aforementioned Decision No. 1 (5-minutes time penalty in application of WRC Article 64.5.3), the Stewards referred specifically to two e-mails sent by the Competitor's representative to the FIA Technical Delegate. It appeared to be clear from their content that the seals on the rear differential of car no. 21 were broken between Rally Portugal 2016 and Rally Italia Sardegna 2016, which would be a breach of the above WRC Article 64.5.3.

The new element now exists in the following:

Upon return back home of the team of Competitor No. 21 (Jipocar Czech National Team) after Rally Italy Sardegna and after checking the part in question, the Competitor's representative informed the FIA that they now discovered that the seals in question are not destroyed and that they wanted to bring forward new evidence under Article 14 of the 2016 FIA International Sporting Code. Upon the request of the FIA, a check was then performed by Mr. Josef Stransky (ACCR Technical Commission President) and Mr. Adam Elias (ACCR Secretary General) and their report confirmed that the seals on the rear differential of car no. 21 effectively are unbroken. Photo documentation was also attached showing that the numbers on the plates were identical to the ones applied at Rally Portugal 2016.

In the light of these new facts and elements thus brought, the Stewards, after the Competitor had expressly waived its right to present additional oral arguments in a hearing and after due deliberation by e-mail,

DECIDE

To annul their Decision No. 1 taken on 9th June 2016 at Rally Italia Sardegna 2016 (Document No. 2.3) and, as a consequence, to establish an amended classification.

Pursuant to the 2016 International Sporting Code Article 14.4 "*The right of appeal against this new decision is confined to the party or parties concerned in accordance with the following Articles of the Code.*"
